Introduction

Dear colleagues from all over the world,

In this seminar, we are pleased to have a special team of researchers from Global South countries to share their insights on a topic of great importance to all nations, expressed in the title: BRICS+: Sustainable Development of Air Transport and Tourism.

History is replete with lessons involving prosperity and disasters brought about by humans. History shows the rise and catastrophic fall of great resilient empires. More recently, the two World Wars exemplify this human evolution chaotic process. The pursuit of prosperity is a universal human desire, but often, those who have attained prosperity feel threatened by the advancements of others, leading to conflicts with catastrophic outcomes for all. After World War II, the United Nations was established, and while not as united as we would like, it brings the message we wish to see in the world, as expressed by the 17 Sustainable Development Goals of the United Nations 2030 Agenda.

The United Nations now has 193 member countries, and among them we still have some ethnic groups aspiring to form their own nations. The skies are crowded with satellites, providing information, biased or not, to everyone. We live in a globalized world of about 8 billion people, where, despite achieving significant prosperity, unacceptable inequalities persist for much of the population. The hegemonic paradigm of the past, where the so-called developed countries dictated the rules, no longer fit the modern world. Today, everyone has access to enough knowledge and can shape their own destinies. The goal is no longer to compete to win others or deprive those who are already prosperous, but to eliminate poverty and achieve sustainable prosperity for all, which may require concessions from elites with unsustainable consumption patterns or power privileges.

This seminar focuses on Sustainable Development for all with an emphasis on Air Transport and Tourism. Because of time constraints, I will only announce the events which will follow this seminar: The first is the Durban University BRICS Research Institute's "The Third BRICS Research Conference, hosted by Fudan University from September 25 to 27 in China, with a call for abstracts open until July 31.
